Dear Parents,

Considering the vast course of Class XI & XII, it has become imperative for the school to register the students of Class X for Class XI by April every year.

Given the implementation of NEP 2020, the school has registered groups with different elective subjects in class XI to accommodate all the class X students and help them make bright careers in their respective fields according to their abilities.

COURSE OF STUDIES AND COMBINATION OF ELECTIVE SUBJECTS

GROUP – I	ENGLISH CORE, PHYSICS, CHEMISTRY, MATHEMATICS, BIOLOGY, PAINTING / COMP. SCIENCE / PHYSICAL EDUCATION for those who want to appear in JEE / NEET)
GROUP – II	ENGLISH CORE, PHYSICS, CHEMISTRY, BIOLOGY, PAINTING / PHYSICAL EDUCATION (for those who want to appear only in NEET)
GROUP – III	ENGLISH CORE, ACCOUNTANCY, BUSINESS STUDIES, ECONOMICS, PHYSICAL EDUCATION / COMPUTER SC. / PAINTING

These are some tentative combinations of subjects; the final list will be notified later.

A minimum of 40 students is required for feasibility in a specific elective / skill subject.

Given the conduct of the Board Examination by CBSE in February-March 2026, the school's Admission Committee plans to complete the provisional admission of internal students by February 2026.

In this connection, an interactive session was conducted on 12.07.2025 with the parents in the Activity Hall for the students of present class X. According to discussion and subsequent decisions of the Admission Committee of the school, the enrolment of the internal students into Class XI shall be held based on the performance of PA-II on 15.09.2025, followed by PA – III scheduled to be held in the second week of December 2025 and subsequently Sahodaya Pre-Board examination in the first week of January 2026, CBSE Board Examination in February-March 2026.

The cut-off marks, as discussed and suggested by the parents, are as follows.

GROUP – I & II

A minimum of 80% in aggregate & 75% in Mathematics (Standard) and Science taken together in PA-II / PA-III / Sahodaya Preboard / CBSE Board Examination out of 80 marks (Theory only)

GROUP – III

A minimum of 70% in aggregate & 75% in Mathematics (Standard) if anyone opts for Mathematics as an Elective in PA-II / PA-III / Sahodaya Preboard / CBSE Board Examination out of 80 marks (Theory only).


Further, it is apprised that the SMC, in its 18th meeting vide resolution No. 18 (8) dated 16.03.2019, has been pleased to offer an exemption of school fees in Class XI to the Top 3% of the total students of Class X and subsequently in Class XII, subject to the condition that they secure a minimum of 90% in theory in the Class XI Annual Examination provided they pursue their studies in our school. The list of Top 3% students shall be considered after completion of the rechecking and re-evaluation process by the CBSE.

Furthermore, according to the CBSE Examination Bye-Laws, a minimum of 75% attendance is mandatory for students to be eligible to appear for the Board Examination. The Board offers a 25% relaxation only in cases of exigencies such as medical emergencies, participation in national or international sports events, or any other serious reasons, if supported by the necessary documents/records. The Board has also introduced the Two Board Examination policy for class – X from the 2025-26 session. The details have already been discussed with the parents in the PTM meeting held on 12.07.2025.


