FOR CONSTRUCTION OF NEW BUILDING BLOCK OF DAV PUBLIC SCHOOL, BALASORE

Sealed quotations are invited by the undersigned from experienced Civil Contractor having valid contract License (B Class and Above) and GST Registration for supply of labour and material for construction of Building block (G+2) storied of 3325.00 sqft. of each floor. They may obtain the prescribed Quotation Form/Tender Form from the office of the undersigned on deposit of Rs. 2000/- (Non Refundable) in shape of DD in favour of "Principal DAV Public School Balasore" payable at Balasore on all working days between 10 am to 02.00 pm from 15.02.2025 to 04.03.2025.

The bidders are required to furnish the completion certificate of works done during the last five years (the value must be 1 Crore and above of a single project) along with the quotation to convince the school authority about their credibility.

The bidder should submit earnest money of Rs. 50000/- (Rupees Fifty thousand only) in shape of DD in favour of "Principal DAV Public School Balasore" payable at Balasore with the quotation form in sealed envelopes superscribed with "Quotation for construction of Building block (G+2) of DAV Public School, Balasore" on or before 04.03.2025 by 02.00 pm.

The quoted rate should be inclusive of all taxes and TDS will be deducted from the Basic amount as applicable. The quotation without valid License, GST Number, ESI Registration Number and Earnest money shall not be considered. The quotation either after the stipulated date or time or except prescribed format shall not be accepted.

There should not be any overwriting or correction in the quotation. If a figure is to be amended, it should be neatly scored out, the revised figure written above and the same should be attested with full signature and date. In the absence of such attestation the quotation is liable to be rejected.

The earnest money will be refunded to the unselected bidders within a fortnight of opening of the quotations without interest. The quotations will be opened cn 07.03.2025 at 12.00 noon in the office of the undersigned. The bidders may remain present physically or by authorized representatives during opening of the quotations. In the event of acceptance of quotation, the bidder will enter into an agreement with the school for timely completion of the work. The earnest money will be adjusted towards Security Deposit which will be kept @ 5% of the Invoice Value for 1 year from the date of completion of the work.

The payment schedule will be as mentioned below:

Ground Floor :			
1.	After completion upto Plinth	-	30%
2.	After completion upto Lintel Level	-	10%
3.	After completion of Roof casting	-	35%
4.	After completion of total Work	-	25%
1.	Floor / Second Floor : After completion upto Lintel Level	-	30%
2.	After completion of roof casting	-	40%
3.	After completion of total work	-	30%

The bidders also can suggest the payment schedule in plain paper both in figure and words. In case of any dispute or variation, the rates quoted in words will be considered. The time of completion is 18 months from the date of work order/signing the Agreement.

If due to reason beyond the School's control, there is delay in completion of the work in time, extension will be allowed. If due to some reason the bidder/contractor does not complete the work in time, <u>he has to pay Rs.1000/- per day of delay as</u> <u>compensation to the school</u>.
